DISABILITY

Disability is a term that includes motor and sensory limitations (e.g., mobility, vision, or hearing impairments). It also includes disabilities resulting from chronic illnesses and syndrome, invisible is abilities, such as psychological and emotional disorders, disorders, learning disabilities, heart disease, diabetes, asthma, arthritis, epilepsy, Acquired Brain Injuries (ABI), and Acquired Immune Deficiency Syndrome (AIDS) are also included in the term disability. Many disabilities vary in degree and type of limitations; therefore, accommodation must also vary and should be tailored to the needs of the individual.

QUALIFIED PERSON WITH DISABILITY

The expression "Qualified individual with a Disability" alludes to a person with a disability who is qualified to participate in any given institute program or activity. With regard to enrolment, a certified individual with a disability must fulfill the scholastic guidelines required for affirmation and meet the scholarly necessities set up for any given course, degree, or certificate program. With respect to employment, training, work assignments, and promotion, a qualified individual with a disability must be able to perform the minimum essential functions of the job. However relaxation shall be allowed as per the Government rules.

ACCESSIBILITY POLICY:

Green Campus Policy

A Green Campus is a place where environmental friendly practices and education combine to promote sustainable and eco-friendly practices in the campus. The green campus concept offers an institution the opportunity to take the lead in redefining its environmental culture and developing new paradigms by creating sustainable solutions to environmental, social and economic needs of the mankind.

College environmental aims and objectives

- The college is striving to develop its institution on a self-sustainable basis in the areas of power, water and cleanliness.
- The faculty, staff and students have to contribute collectively to develop an eco-friendly sustainable campus and disseminate the concept of eco - friendly culture to the nearby community and wherever possible.
- Awareness creations about environmental issues among students and employees including climate change.
- Measure and reduce environmental emissions/ footprints

In pursuing our program of improved environmental performance, we thrive upon following major areas:

Waste Management

- To increase the green cover in and around the campus.
- To adopt methods for waste segregation
- Take appropriate actions to reduce or recycle municipal waste inside the campus.
- To manage, collect and dispose e-waste appropriately.

- To reduce hazardous waste and its management.
- Actions taken to reduce consumption of plastic in the campus.
- To encourage paperless work culture and recycling/ reuse of paper.
- Display waste management instructions/alerts at prominent/relevant Locations in the campus.

Water Management

- Adopting following measures in campus to reduce water consumption
 - Grey water in flushes
 - Rain water harvesting
 - Change of taps which are either more water efficient or sensor based taps
 - Use of recycled water for watering plants, trees etc
- Display water management instructions/alerts at prominent /relevant locations in the campus.

Climate Change

- Suitable action taken to reduce green house gas emissions due to energy consumption
- Use of energy efficient equipments in laboratories/ classrooms/ canteen, this can range from air conditioners, refrigerators, condensers etc.
- Monitoring the entry of vehicles in the college in terms of their fuel efficiency/ hybrid/ battery operated vehicles..
- Promoting the use of public transport.
- To establish a system for preparing college/environmental inventory.
- Creating awareness by organizing seminars, debates, activities related to climate change, environmental protection, and environmental issues.
- Promoting some projects/experiments in the education system as part of regular curriculum which is related to environmental aspects.
- To encourage the concept of green brigade so as to maximize the students involvement.

We intend to pursue a programme of continuous improvement in our procedures, practices and review the policy on a regular basis to evaluate continued relevance and to monitor compliance.

Solid waste management Policy

- Solid waste is segregated as degradable and non-degradable and handed over to the concern authorities under MoU as a part of ITC – WOW and clean and green campus.
- The block safai workers in each floor collect, clean, segregate and compile the waste in the dustbins (Green and Blue) provided at each floor. The floor dustbins are emptied in containers/dustbins provided for each block and is taken to the Proddatur Municipality.
- Sufficient quantity of bins are provided at wet waste prone areas like cafeteria, food processing along with daily collected vegetable waste, food waste is treated and converted into vermin compost and is used as manure further to develop garden and plants growth in the campus.
- Overcompensating is a viable, cost effective & rapid technique for the efficient management of organic solid wastes.

Liquid waste management Policy

- Vaagdevi Institute of Technology & Science has well-constructed drainage system connecting with closed water tank and tank is cleaned regularly.
- In chemistry laboratory, organic solvents are collected in a special container, chemically compatible, securely fitted with a tight-fitting lid and labeled as hazardous waste and safety aspects before utilizing them.
- Corrosive liquids are appropriately diluted to a pH between 5.5 and 10.5 and then, these can go down the drain.
- The labs are well ventilated and spacious. 24-hour water supply is available in chemistry and environmental engineering lab and safety of the students is given more priority in planning a facility.

Biomedical waste management Policy

Bio-chemical wastage is significantly less because of the healthy environment in the institution. The biomedical wastage produced due to medicines used in the dispensary when the necessity arises is collected in the dustbin and safely disposed of.

E-Waste Management Policy

E-Waste generated by electronics equipments such as floppy, memory chips, motherboard discs, and cartridges, Printers, Fax and Photocopy machines are recycled properly and replaced buying a new machine buyback option is taken for technology up gradation. The e-waste generated from hardware which cannot be reused or recycled is being disposed of through vendors. Condemned batteries and computers are disposed by selling to the vendors and agencies.

Environmental Policy

In the light of ban on use of single use plastic products by AP state Government from October 2nd, 2018 onwards the staff and students of Vaagdevi Institute of Technology & Science are informed to adhere to avoid the use of plastic in and around college and hostel campus with immediate effect and to make the campus clean and green.

Further all are requested to kindly cooperate and replace it with environment friendly alternatives.
